- a. Treasurer's Report (Mark) None
- b. Registrar's Report (Judy) None

4. Old Business

- a. Ratings Sheet Makeover (Jeffry) No update as of now. Still in progress
- b. BCC Planning
 - i. The USAV Tournament Selection Process will be based on a multi-person committee for each gender headed up by Mark based on the following three categories:
 - 1. This Year's or Last Year's Nationals Attendee
 - 2. Strength of Roster
 - 3. Frequency of Yankee Play / Longtime Yankee Contributor
 - ii. Player's Party is scheduled for the Saturday night of the BCEC tournament.
- c. RCO Men's Cap (Max 2 points on guys in coeds)
 - i. This rule was re-written by Jeffry via email and approved by the board
 - ii. "For participation in tournaments, a team rating will be calculated by totaling the individual ratings of the top six players on each team's roster for that tournament. This total cannot be more than 3 points above the tournament level.

- iii. For co-ed or reverse coed tournaments, only the ratings of the top three men and the top three women on the roster will be counted and must be no more than 3 points above the tournament level. In addition to this, the total of the top 3 male player ratings cannot be more than 2 points above the tournament level (for B-and lower tournaments) or 3 points above the tournament level (for B and higher tournaments). The total of the top 3 female player ratings cannot be more than 3 points above the tournament level for any level."
- d. Board Elections (Judy)
 - i. The board selected Crystal Huntoon, Sarah Dufault and Krissy Norrman as the Yankee Board nominating committee. Elections will take place from May 3rd to June 8th and results will be announced at the Yankee Picnic. Glenn Corwin will administer the voting again.
